Law at UMW

The University of Mary Washington offers several paths for students interested in attending law school.

The Philosophy Department offers a **Pre-Law Concentration** within the major, as well as **minors in Law and Philosophy and Practical Ethics.**

The American Bar Association recommends that students choose a major that interests them, and participation in the Pre-Law advising track is open to students of any major.

The **Pre-Law Club** is open to all students interested in law. The Society holds LSAT study sessions, events, trips and workshops throughout the year.

Paths to Law School

3 + 3 with George Mason

UMW has an accelerated partnership option with the George Mason University's Antonin Scalia Law School, allowing students to graduate with their bachelor's degree and J.D. in six years instead of seven.

After three years at UMW, students can apply for admission to the Antonin Scalia Law School. Instead of their senior year at UMW, the credits earned during the first year at Scalia Law School count as elective credits at UMW, as well as towards the first year of law school.
